What is Codependence? Formation of the false person/adapt to the "cr@p"

There is much said about what a codependent does and little about what a codependent is. A codependent is a false person formed by the psyche to adapt to the trauma of childhood. Due to the neglect/abuse in childhood the false person is formed to protect the true self. The codependent false person assumes a role to play in order to survive childhood. The false person also falsely assumes the values of the society in which it exists. Is the false person a gift or a curse? Codependency has been called a disease of immaturity. Is that true in the literal sense? Does formation of the false person lock the psyche into an immature state of development? Does the false person form an invisible barrier that prevents the brain from fully developing due to lack of stimulus? Does the neglect/abuse during childhood cause a lack of conscience, impulsivity, and destructive behaviors? Is codependency an affliction or an addiction? Are addicts codependents first? In shutting out the bad does the false person also shut out the good? Does codependency and all addictions kill the pain of not being able to feel? If interactions with people caused the situation, do interactions with people cure the situation by changing the behaviors of the false person and allowing the true self to develop, mature and emerge? The American Psychiatric Association has recognized codependency as a separate disease and now has a DSM listing. Will insurance companies now pay for treatment for codependency by therapists and rehab centers? Does this lead the way to have a licensed codependency counselor license - an LCC? To have separate college courses devoted to codependency in psychology departments. Also seminars in codependency counseling, which would give CEU credit for LPC, LCDC and others.
